## **Fighting for Freedom in Greece**



### **Short Biography.**

My name is Ioannis Demertzis, I am a telecommunications and IT technician, owner of a private radio station and other electronic media, former editor of an independent local weekly newspaper, a journalist by extension and a member of the Association of Journalists of the Magazine and Electronic Press of Macedonia Thrace (Greece).

I have been involved in exposing the COVID fraud since 2020.

### **How I started investigating the COVID scam.**

At the beginning of the year 2020, from the day the closure of our national borders was announced, in conjunction with the largest global military operation called "**Defender Europe**", I found that the events were not as we were told in the media, but something different and very big was happening.

### **The first articles and evidence against covid-19.**

I started the research, because it was very interesting and almost and after several days of searching the internet, I found several interesting facts and so on March 25, 2020, I wrote the article entitled "**Coronavirus: All the Truth That Wouldn't Tell You in Systemic Media**".

Comprehensive research, with all the necessary facts, so that everyone can understand the whole background, how we got here, with enough historical and medical facts, facts and evidence.

Medical facts with proof that there is no physical form of the Corona virus as it was presented to us, but for a biological weapon that the Deep State were intended to spray into the atmosphere, the prevention of this, but also how this was used as a cover-up operation to carry out mass arrests and slowly reveal the truth about adrenochrome and of course how the evil Khazarian Mafia had spread and enslaved humanity.

As I continued my investigation, in early June 2020, I received information that arrests had been made of members of the Greek Parliament, including the Prime Minister and the Deputy Prime Minister.

So I thought it appropriate to announce it publicly, but instead of seeing the joy and enthusiasm of the Greeks, I was harshly attacked by the "patriotic" sector.

So I found that there is no pure patriotic space, but a directed patriotic space, which is doing everything to defuse the anger of indignant citizens against the government, but also to delay people from waking up.

In mid-July, a friend and leader of the special guard of Blessed Archbishop Christodoulos, informed me that an operation to assassinate more than thirty (30) people had been set up by people of the Greek government. Individuals like myself and others who express the opposite view from the pandemic narrative, but I was at the top of the death list because I had put out information that was true about everything that was happening.

### **The documentary about the awakening.**

Sometime later, at the urging of a friend and with his valuable help, I made a documentary about the Great Awakening. A documentary in which I explained everything that was happening around us and in particular explaining about who Q and QANON are and of course about the great awakening that is happening now.

### **The Orcodosia claim and what it is.**

At the beginning of 2021, I learned about a very serious issue, perhaps the most serious issue, which is the central pillar for law and democracy and which is the key element, for the existence of a legitimate State, a legitimate government.

This is Oath-taking (Orcodosia), which, apart from referring to an oath, as a concept, in our case, with the concept of Oath-taking, we are referring to a basic right that a citizen has !

The Oath of Allegiance, takes place with the coming of age of each Citizen - Citizen so that he can still be a visible and visible Citizen - Citizen, to undertake with conscientiousness the duties of the citizen and most importantly to possess legally the legal right to vote and be elected.

Orcodosia has been established since 1846, during the reign of Otto.

Specifically, it follows from Article 6 of Law 9 on 8 May 1846.

So at that time I submitted the request of the Orcodosia with a bailiff, to the Mayor of my city, to the District Governor, and to the Metropolis.

Of course, even to this day I have not received a reply.

It is useful to mention that the Petition of Orcodosia, consists of 233 pages and is divided into 3 main topics.

The Political Right of Orcodosia and recognition of legal personality ( Pages 12 - 132).

The Criminal of Government, which for the first time in the world the government is tried with a sentence of 3 years in prison with probation ( Pages 132 - 204 ).

Finally, other matters the author's affidavits ( Pages 205 - 225 ).

The main one of all that it is addressed to the legal chair of the world's universities.

Consider that at the moment, 191 states are dealing with it, with 192 Greece, which has a penalty ! With a country whose government is illegal.

## **The seizure of all my contributions by the IRS.**

In June 2022, the IRS, starts massive seizures on my income, for a debt I had, of course it was obvious that this was in retaliation for my doing against COVID measures and of course, from that time on, I cannot have legal income. So, I am forced to ask for donations and work wherever I can find work.

The IRS, because of the fact that what they did in the way they did it was clearly illegal and abusive, I started a legal battle against them. So, I filed a big lawsuit in November 2022. This lawsuit, it involves many great issues, such as the Bretton Woods Treaty and others, which of course is ongoing and involves all Greeks and of course the rest of the world.

## **The lawsuit against all those responsible for the Covid-19 fraud.**

Because I couldn't wait if someone in my country would do something on a legal level to fight against all those who supported the COVID measures and already abused the people, I tried to raise some money and start a big lawsuit against all those responsible.

This lawsuit is declaratory in nature. That is, if it is formally recognized that all these measures were wrong, then anyone who wants to, will be able to prosecute anyone who has harmed them.

It concerns all Greeks. Of course, it is true that the main reason I made it was for our children, who unfortunately do not know and are the victims of all this criminality, of the communists.

Due to the fact that subsequently others from Greece declared their interest to take part in this movement, we filed an additional intervention of the lawsuit.

The sad thing is that only about 70 people took part from all over Greece.

## **The lawsuit against the Greek Government for the ordeal and the retaliation against citizens.**

On Tuesday, May 16, 2023, at the Single Judge Court of First Instance of Thessaloniki, I, together with the legal representative, on the occasion of a very sensitive family matter, filed, a declaratory action, of civil right and clarification of legal retaliation.

On the basis of which, the elections of Sunday, May 21, 2023, can NOT be held before the Judicial Authority of the Greek Justice, Article 26 para. 3 of the Constitution, without the issuance of the regular or extraordinary decision due to the National reason of holding the Parliamentary Elections of Sunday, May 21, 2023.

This was the lawsuit I filed on the very serious issue of the Orcodosia.
