



## PREFACE

(Historical Origin of Filipino People's Treasury)

Ferdinand Marcos, which appeared thereafter thru Federal Agreement dated September 10, 1976 that Marcos was paid Philippine Islands sometime on year 1976 worth US\$ 20, 000, 000 or 10, 000 metric tons of gold as comparable to precious metal value and Spain successfully obtained the Islands by using that Carpio's Treasures and there and there, Spain occupied the Islands for more than 300 years until Dr. Jose Rizal came and reconstituted those wealth in the name of the People of the Philippine Islands under White Vatican Account and the death of Dr. Rizal brought Spain under trouble and end of illegal occupation and with the pretending aid of the American Authorities, that caused thereof to end their conflict and made a Treaty and on December 10, 1898 the Treaty of Paris were ratified by and between the United States of America and Spain and paid Spain the sum of US\$ 20, 000, 000 of total land area covering the Islands of Luzon to the Islands of Sebeh with a constant measurement of 452, 000 sq. km. under its previous name: Titulo De Propriedad Numero 4138 and after the ratification of said Treaty, the US Authorities occupied the Islands under that Treaty without any confirmation if the People of the Islands will be permitted by them to occupy the land and thru that Titulo that possesses by Dr. Rizal, it was been sold by Gen. Emilio Aguinaldo. The entrance of year 1900 was so crucial for mankind when there an occurrence of World War 1 and 2 which the host of WW I forcibly abated and debated with other countries in Europe about the equal sharing of benefits to be collected from White Mongolian and Vatican Account and thereafter the American Authorities forcibly left the Islands during World War 2 including the Original Documents of the Original Certificates of Title no. 779 under Survey Plan no. II - 4509 and thereafter the American Authorities reoccupy the Island without that documents that already addressed by UN General Assembly Pres. Carlos P. Romulo that the United States of America already left the Islands including those Original Documented Land Title and Survey Plan and the Assembly agreed not to practice their greed to reoccupy the Islands but agreed as stated that the Islands will be under supervision of the US Authorities and they will be given the Islands an Independence if they will be bought the Islands in the sum of US\$ 100, 000, 000 within 50 years from time since the United Nation Organization was established. And before the Axis Powers fall into the Allied Powers, they entered Multiple Assets and Properties of the Axis Powers which distinguished by the Axis Powers as both King Carpio and Dr. Rizal Assets and Properties and was admitted by Pres. Karl Donitz that those loots were the belong to the Philippine Islands cause he admitted that both Adolf Hitler (son of Ignacio Enrique Coronado) and Tomoyuki Yamashita (son of Judge Alfonso Pijao) were a half Filipino Natives and they wanted their fathers to be satisfied with their loots not intended for them which Ignacio Enrique Coronado and acclaimed as Dr. Jose Rizal and Judge Alfonso Pijao was acclaimed as Bernardo Carpio and those Treasures were set into more controversies among those war ravaged and non war ravaged countries that caused for King George VI to establish the World Court to promulgate Judgment over said issue under ICJ case no. 1425 and it reconsidered to reaffirm this Judgment sometime on year 1975 and Pres. Ferdinand Edralin Marcos filed and time deposited, under White Eagle Account and reinserted under this Account the White Mongolian and Vatican Account, some compensation assistance from Germany, Italy and Japan and some of these loots to some Banks in Europe both under Certificate of Deposits that to be matured from year 2000 to beyond which caused for the treasure pleaders to concentrate or point their claims over said deposits that sponsored by multiple treasures identified as loot of the Axis Powers which Pres. 





Akong si Ferdinand Edralin Marcos isang Filipino na may Legal na Edad, Kasal kay Imelda Romualdez Marcos at Pangulo ng Pilipinas sa kapangyarihang ipinagkaloob sa akin bilang Pangulo ng Pilipinas at bilang dating Tagapangasiwa, Tagapag-ingat, Tagapamahala at Tagapirma ng Dakilang Manglilikha na may-ari ng buhay at tinitatangkilik ng mundo sa sagrado niyang Kayamanang Materyal at Espirituwal ay buong puso at kaisipang maghabilin, ganap na tumalikod at magsalin ng aking taglay na buong karapatan at kapangyarihan, nang walang pag-aalintangan, paghahabol at maiwan sa aking kapangyarihan at karapatan sa kayamanang espirituwal at material na ipinagkaloob ng Dios na Lumikha, sa aking itinalaga at pinagkatiwalaan bilang Tagapangasiwa, Tagapag-ingat, Tagapamahala at Tagapirma.

Sapagkat, ang Pilipinas ay isang pinakamakapangyarihan at pinakamayamang bansa sa mundo dahil sa taglay nito ang magandang kaugalian at kultura ng mamamayan, magandang kagubatan, mga katangi-tanging kabundukan at mga likas na yaman at binubuo ito ng isang libo isang daan na isla sa buong kapuluan, ang mga mamamayan sa Pilipinas ay kinikilala bilang Pilipino ng mundo ay may katangian taglay na masunurin sa mga magulang at batas, disiplinado, mayaman sa pakikisama, may kalinisan ang puso at kaisipan, magalang, matalino at higit sa lahat ang mga Pilipino ay may takot sa Banal at Buhay na Dios bukod pa sa magandang katangiang taglay sa katauhan ng mga Pilipino sila rin ay may Legal na Karapatan at Kapangyarihan sa bansang Pilipinas at sa napakalaking Kayamanang Materyal at Espirituwal na nakatago sa buong mundo na siya dating ipinagkatiwala at itinalaga ng Diyos sa akin alinsunod sa banal na kalooban ng walang hanggan Dios na Buhay at Hari ng Mundo at ng Kalangitan at alinsunod sa itinatadhana ng batas, akong lumagda ay buong pusong nagpasinaya, naglihim at nag-ingat na magbuo ng kasulatang ito at ng mga mahiwagang dokumento na may mababaw na pagkakasalin sa Ingles at itong nakasalin sa tagalog na ipinagkaloob sa aking Itinalaga at Itinalagang Tagapamahala, Tagapag-ingat, Tagapangasiwa at Tagapirma magnula pa noong Agosto 25, 1983 hanggang sa araw na ito nang walang anumang mga saksi, notaryo publiko at mga opisyal na selyo ng aking opisina at nang walang nakakaalam sa sinumang aking mga itinalagang at opisyales at employado ng aking pamahalaan at maging sinumang mga miyembro ng aking pamilya at ang kanilang mga katiwala maliban lamang sa akin na nag-iisa at sinadya kong isulat ang mga mahiwaga at mababaw na mga kasulatan sa wikang Ingles at Tagalog upang ang lahat ng mga mataas, gitna at mababang klaseng mamamayan o lipunan sa Pilipinas at sa mundo ay medaling maunawaan ng mga nilalaman na nakasulat sa lahat ng aking mga dokumento na mailalahad sa hinaharap at ang anyo ng mga kasulatang Ingles na ipinagkaloob ko sa aking Itinalagang Katiwala, Tagapamahala at Tagapirma ay nagtitaglay ng mababaw na pagkakasalin sa Ingles ngunit nagtitaglay din ito ng espirituwal at materyal na nilalaman. Ang lahat ng mga taong babasa sa nilalaman ng kasulatang ito ay pinag-iingat na ito ay hindi maaaring usig, tuligsain, paratangang huwed na kasulatan at iba pang mga negatibong aspeto laban sa mga nilalaman ng mga kasulatang ito at ng mahiwagang mga dokumento na ang nilalaman ay mababaw na pagkakasalin sa wikang Ingles at ang sinumang mag-uusig, magbabalewala, magpaparatang, hindi maniniwala at iba pang uri ng negatibong aspeto ng kaisipan at kalooban ay walang pagsalang mapaparusahan ayon sa itinakda ng batas ng Dios ng Kalangitan at ng Pilipinas, kahit na magbago pa ang Saligang Batas na itinakda ng mamamayan, makatotohanan at mangyayaring maparusahan ayon sa itinakdang kalooban ng Dios na nasa Kalangitan laban sa ganitong tao katulad ng malalang karamdamman, pagkakasangkot sa gawaing Kriminal at Biglaan at Malagim na Kamatayan sapagkat aking napaturuan sa mga karanasang aking napagdaanan hanggang sa aking pag-upo at maaaring pagpapatsik sa akin bilang Pangulo ng Pilipinas na ang Sagradong Kayamanan ay nagtitaglay ng Mahiwaga, Banal at Makapangyarihang Aspetong Espirituwal at aking sinadya na paghaluin ang Ingles at Tagalog sa aking inihandang Huling Kasulatan at Kalooban.

Sapagkat, ang pinagmulan ng Banal na Kayamanang Espirituwal at Materyal na nasa pag-iingat ng lumagda ay nagsimula noong mahigit sa isang libong taon na ang nakakaraan, na sadyang itinago sa kasaysayan at itinuring na isang alamat lamang, sa pamamagitan ni Haring Bernardo Carpio, ang aking espirituwal na kapatid, na espirituwal sa pagkakatawang-tao ni Samson, Noe at San Pedro at nabibilang siya sa Maharlikang Pamilyang Portuges, sa katunayan, ang unang taga Europa na tumuklas sa Pilipinas ay ang bansang Portugal at mismong pamilya ni Haring Carpio matapos tumakas ang kanilang angkan noong panahong nilulusob ang Europa ng mga Mananakop na mga Muslim at siya ay tinulungan ni Dali Daliktuna, na nakilala bilang si Maria Banahaw, isang maalamat na Reynang Diwata at Sagradong Tagapag-alaga ng Bundok ng Banahaw sa Probinsya ng Quezon, Pilipinas at sila ang tunay na tagapangasiwa ng White Mongolian at White Sunflower Account. Ang mga kapitbahay na Asyano ay lumipat sa Pilipinas at sila ay pinamahalaan ni Haring Carpio na may taglay na mapaghimala at pambihirang lakas ayon sa pagkakatalaga sa kanya ng Dios na Lumikha, ang mga Asyanong nakatira sa Hilagang Bahagi ng Mundo tulad ng China, Korea, Japan at Mongolia ay dumating at tumira rin sa Pilipinas para sa

kalakalan. Dahil sa ganap at hindi sinasadya na pagtuklas, hindi inilahad ng ilang mga mananaliksik at mananaysay na ang Pilipinas ang hindi inaabangan imbakan ng mga nakaw na yaman sa pamamagitan ng mga pirata. Dumating dito ang mga Khamag na taga Mongolia kasama na ang kanilang mga kaalyado para tuklasin ang Pilipinas at dahil sa kaaya-ayang kagandahan ng Pilipinas, ng mga likas nitong yaman at ni Mariang Banahaw at mga kapatid nitong mga diwata na sina Mariang Makiling, Sinukuan at Cristina lumikha sila ng isang Kasunduan para kay Haring Carpio na hiniling nilang makasama bilang kanilang asawa ang apat na magkakapatid na diwata na nasa anyo ng katawang Iupa, ayon ito sa sinaunang titik ng Pilipinas, nguni't tumanggi ang kapatid kong si Bernardo Carpio at makuha lamang nila ang mga diwata kung si Carpio mismo ang gagawa ng Kasunduan at sumang-ayon nga ang mga dayuhan dahil sa laki ng panganasa nilang mga Dayuhan sa magkakapatid na diwata'y napang-sang-ayon nga itong mga Dayuhan na hindi alam na ang nilalaman ng binagong Kasunduan ay ang bawat isang bagay na inilabas nila mula sa Pilipinas ay babayaran nila ito nang doble sa bawat araw sa Pilipinas at nakasaad din doon na ang lahat ng matuntungan nilang Iupain ay madadamay sa kanilang bayarin at bilang panunubok ng aking kapatid na Carpio sa kanilang katapatan sa Kasunduan ay pinabalik nila muna ang mga ito sa bansa nila upang mapauwi ang naturang Kasunduan kasama ang ilang toneladang mahahalagang bato at bakal sa kanilang pag-lisan nguni't nang matutunan nila ang Kasunduan ay pinawalang-halaga nila ito at sinimulang lusubin ang Pilipinas para sakupin nguni't dahil sa taglay na maliwagang lakas ni Carpio ay hindi nila ito maigupo bagaman si Carpio ay nabuhay sa edad na mahigit na dalawang daang taong gulang kaya nagpasugo pa sila ng mas maraming powers mula sa Hilaga nguni't napigilan sila nang yumanig ang Iupa dahil sa pag-uumpugan ng bato sa Bundok ng Montalban, Probinsya ng Rizal, Pilipinas nagsimula ang pangginginig ng Iupa at nagsitakas ang mga mananakop na mga dayuhan mula sa Pilipinas nguni't sa kasamaang palad ay nalubog ang kanilang barko dahil sa lakas ng pagkakayanig ng Iupa at naapektuhan ang mga alon sa dagat at sinalpok sila at nilubog, isinakripisyong si Carpio ang kanyang sarili bilang isa na namang alay at namagitan siya sa nag-uumpugang bato sa naturang ligalig na bundok at noon pa ito babala sa panunuri ni Malerta Tikila o mas kilala bilang si Maria Sinukuan, isang maalamat na Reynang Divata at Sagradong Tagapag-alaga ng Bundok ng Sinukuan sa Probinsya ng Pampanga, Pilipinas at ni Kaara Maraka o mas kilala bilang si Mariang Makiling, isang maalamat na Reynang Divata at Sagradong Tagapag-alaga ng Bundok ng Makiling sa Probinsya ng Laguna, Pilipinas na ang mga dayuhan ay mananakop ng maraming kaharian sa mundo at dahil sa kanyang pagkakaliho sa mga dayuhan ay mayayanig ang Iupa at siya mismo ang magiging isang maliwanag na sakripisyong upang tumahimik ang Iupain ng Pilipinas sa madalas nitong pagyanig at ang imperyo ng Mongolia ay lumusob at nanakop sa halos tatlong-ikaapat ng kontinente ng mundo at nag-iwan sila sa bawat bansang kanilang sinakop ng pagkawasaki at mga kasamaan habang hindi nila namamlayan ang kanilang naging kasunduan ni Carpio na nakasaad doon na madadamay din ang lahat o anumang mga bansang mapupuntahan nila sa pagbabayad nila sa kanilang utang sa Pilipinas na doble din mula sa simula ng kanilang mga paa ay lumapag sa mga banyagang Iupa at pagkatapos ng Ikalawang Digmaang Pandaigdig, nauhuha ng Soviet Union Socialist Republic (USSR) ang mga Mongolian Treasures kasama ang mga detalye nitong nakadokumento na may kinalaman sa kanilang Kasunduan ng mga taga-Mongolia kay Haring Carpio. Ang dokumentadong kasunduan na ginawa ni Bernardo Carpio at ng kanyang mga kaharap na dayuhan ukol sa naunang bersyon ng Sagradong Kayamanan ay nakatago na sa World Trade Center, New York, USA na nauhuha ko kay Pangkalahatang Kalihim ng Unyong Soviet Hen. Leonid I. Brezhnev noong panahon ng aming pagbisita sa USSR.

Sapagkat, matapos isakripisiyo ni Haring Bernardo Carpio ang kanyang sarili sa nag-uumpugang bato sa Montalban, Probinsya ng Rizal, Pilipinas, ang ilan sa kanyang mga angkan o lahi ay napadpad sa Hilagang Asya tulad ng Tsina, Japan, Korea at Mongolia at ang ilan ay sa mga bansa sa Middle East at Europa batay sa makasaysayang impormasyon isiwatalat sa akin ni dating United Nation President at Foreign Affairs Sec. Carlos P. Romulo, ang naturang impormasyon at ang mga listahan ng mga tala-angkan ni Bernardo Carpio na nasa pag-iingat ni Sec. Carlos P. Romulo bago siya ay pumanaw noong ika-15 ng Disyembre, 1985 ay sinadya at lihim ko itong itinago sa World Trade Center, New York, USA.

Sapagkat, sa kawalan ng kaalaman ng ilang mga mananaysay sa Pilipinas, ang aking kapatid na si Bernardo Carpio ay naging unang Hari sa Pilipinas at siya umabot nang mahigit sa 200 taon at sa panahon ng kanyang mga pamamahala, mataman niyang sinukat mag-isa ang ang eksaktong lawak ng Iupa sa Pilipinas at ito ay nahahati sa iba't ibang isla mula sa mga Hilagang Kapuluhan hanggang sa Katimugang Kapuluhan, Mula sa Silangan hanggang sa Kanlurang Kapuluhan noon ang Pilipinas ay nasa ilalim ng kanyang kapangyarihan at pamamahala at iginuhit niya ang unang larawan ng mapa na hindi tumpak sa tunay na aryo ng mapa ng Pilipinas sa kasalukuyan sa balat ng kalabaw, nang makalipas na ang mahigit-kumulang na 400 taon nagsidatingan na rito ang mga Kastila sa pangunguna nina Magellan nguni't sa kasamaang palad ay napatay sila ni Datu Lapu-Lapu nang maramdamang nilang sila ay sasakupin ng mga dayuhan sa pamamagitan ng dala nilang araling Katolisismo nang mawala na si Magellan at Datu Lapu-Lapu sa kasaysayan ng buhay ay nagsidatingan uli ang mga Kastila sa pangunguna nina Hen. Sapagkat, Dr. Jose Protacio Rizal Mercado y Alonso Realonda, na inaangkin din ng lumagda bilang isang espirituwal sa pagkakatawang-tao ni Moises at San Jose na tumayong Ama ng Panginoong Hesus at isa sa aming espirituwal na kapatid na lalaki, ay ipinanganak noong Hunyo 19, 1861 at sa kanyang paglaki ay nagigising ang kanyang diwa at pansin sa lumalang kawalan ng pitagan at pag-abuso sa kapangyarihan ng mga pamahalaang Espanyol laban sa mga Filipino at siya ay tinulungan sa pamamagitan ni Leonor Rivera, na

nagkatawang-tao muli bilang Maria Sinukuan sa panahon ni Dr. Rizal ngunit ang kanilang kapalaran sa pagtulong sa mga Pilipino at pagmamahalan ay sadyang mailap, katulad nang naganap sa kapalaran ng pagmamahalan ng isa pa naming kapatid na si Antonio Diaz Santiago at Graciana Delos Santos, na kinikilala rin ng magkakapatid na diwata noong panahon ni Rizal bilang si Maria Cristina o Maria Magdalena at Batsheba na mga kilalang tauhan sa banal na kasulatan dahil sa mga bagay-bagay tungkol sa pamilya nina Dr. Rizal at Leonor Rivera at sa katauhan ni Dr. Rizal sila ay nagkahiwalay nang magpunta ang pamilya nina Dr. Rizal sa ibang bansa upang mag-alarilisa ang Legal at Tunay na tagapangasiwa ng White Vatican at White Crystal Account.

Sapagkat, Ang isa sa kamukha ni Dr. Rizal mula sa siyam na mukha at kamukha rin ni Dr. Rizal noong siya ay nasa batang edad pa na si Antonio Diaz Santiago at kilala rin bilang espirituwal sa pagkakatawang-tao ni Haring David, Jacob, Adan, Josias at Dimas, ay ipinanganak sa Hunyo 5, 1869 sa Bacolod, Lalawigan ng Negros, Pilipinas sa pagkadлага ng kanyang ina at isang paring Kastila na walang nakakaalam na si Antonio D. Santiago ang tanging tagapagmana sa mga kayamanan ng Imperyo ng Persya, Griego at Romano ayon sa pagkakabanggit ng Reyna Rehente ng Espanya na si Reyna Maria Cristina ipinaalam din ng Reyna Rehente kay Rizal ang isang nakatagong pagkatao ng aming kapatid na ito sa espirituwal at ayon sa pagsubaybay kay Antonio na siya ay apong lalaki ni Muhammad Al-Muhammad, ang tanging tagapagmana ng pamilya ng Propetang si Muhammad at ng ika-10 porsyento mula sa mga nabuong Kayamanan ng mga Muslim sa mundo at ni Prinsesa Duanshun na isa ring tagapagmana ng lahat ng mga Kayamanan ng lahat ng mga naging Emperador ng Tsina magmula noong sinaunang panahon ng bansang Tsina hanggang sa panahon ni Emperador Daoguang. Si Antonio Diaz Santiago at ang katuwang na si Graciana Delos Santos na siyang kinikilalang Maria Cristina ng kanyang mga kapatid na diwata ay siyang legal at tunay na tagapangasiwa ng White Dragon at Kiram Account. Ang mga naturang dokumento na nagsasaad ng lahat ng impormasyon sa talambuhay at kayamanan ni Antonio ay ipinagbilin sa akin ni Leonardo S. Manicio, Sr. o mas kilala bilang si Nardong Putik bago ito namatay at isa sa apo ni Antonio Diaz Santiago at natanggap ko rin ang isinulat na bilin ni Antonio kay Dr. Rizal at lahat ng ito ay sinadya ko ring itago sa World Trade Center, New York, USA.

Sapagkat, si Dr. Rizal ay nagpunta sa Espanya upang matugunan ang kahilingan ng kanyang malayong kamag-anak na si Reyna Maria Cristina, Reyna Rehente ng Espanya na bilhin na ang Pilipinas at upang talakayin ang mga pamamaraan ng pagbenta ng Espanya sa Pilipinas kay Dr. Rizal at sa ilalim ng kasunduan at batas sa pagkakabili at pagtatala ng titulo ng Pilipinas na pinamagatang Titulo de Propiedad Numero 4136 ay binayaran ito ni Dr. Rizal sa kabuuhan halagang \$ 10, 000, 000 o 10, 000 piraso ng mga barang ginto na kinunan pa mula kay Maria Clara Del Prado (Maria Banahaw noong panahon ni Dr. Rizal) gayunpaman lahat ng ebidensiya, record, kabilang na ang mapang ginawa ni Haring Carpio at ang pagkakabenta ng Pilipinas kay Dr. Rizal ay tinalakay at ibinigay ng Espanya sa Estados Unidos ng Amerika kaya binayaran ng Estados Unidos ang Pilipinas sa halagang \$ 20, 000, 000 kapalit ng kanilang pagpapatibay sa kanilang Treaty of Paris o mas kilala bilang Kasunduan sa Paris na pinagtibay noong Disyembre 10, 1898 sa Paris, France at sa gitna ng walang kamalayan ni Dr. Rizal tungkol sa kapalarang sasapitin niya matapos matanggap ang naturang Titulo. Si Dr. Rizal matapos na makatarungang mibili ang Titulo de Propiedad ang Numero 4136 na siyang sumasaklaw para sa buong Pilipinas ay naaresto sa bisa ng maharihang atas bilang 01-4 ni Haring Alfonso XIII laban sa kanya at sa kanyang nabiling rehistradong dokumento ng lupain sa buong Pilipinas at ipinabilanggo pagkatapos ay pinarusahan ng kamatayan noong Disyembre 30, 1896 sa Bagumbayan na mas kilala bilang Luneta ngayon na siyang nagdulot sa mga Pilipino upang ilunsad ang madugong rebolusyon laban sa mga Namamahalang Kastila sa Pilipinas. Bago pa lumalala ang pag-uusig ng gobyemong Kastila laban kay Dr. Rizal at pagkababa niya sa daungan ng Maynila mula sa ibang bansa ay ipinagkativala niya ang nasabing dokumento kay Engracio San Pedro, isa sa kamukha ni Dr. Rizal at sinabi niyang maglimbag ng maraming magkakaparehong anyo ng nasabing titulo upang maligaw ang mga namamahalang Kastila sa Pilipinas sa pagkumpiska ng nasabing titulo gayunpaman ang Orihinal na Dokumento ng nasabing Titulo ay ipinagkativala ni Dr. Rizal, mula sa pagkakahiling nito kay Engracio San Pedro, kay Gat Andres Bonifacio (ang aming kapatid na espirituwal sa pagkakatawang-tao ni Bernardo Carpio) kung saan ay nagsilbi itong Titulo bilang malakas at matatag na batayan at kasulatan upang pabagsakin ang mga mananakop na mga Kastila matapos ang pagpapatupad sa kamatayan ni Dr. Jose Rizal noong Disyembre 30, 1896, ang mga Pilipino ay nagsimulang maghimagsik laban sa mga Kastila habang ang Katipunero ay abala sa pagbabalangkas laban sa mga Kastila ay abala naman ang Traynor at Hindi Bayani na si Hen. Aguinaldo sa Orihinal na Kopya ng Titulo de Propiedad Numero 4136 sa Opisyal ng Amerikanong Sundalo sa Pilipinas nagkakahalaga ng \$ 5,000,000 ay namahala ang mga Amerikano sa Pilipinas ayon sa kanilang Legal na Karapatan sa Rehistradong Lupain. At sa bisa ng Kautusan ng Pangulo ng Estados Unidos ng Amerika, ang Philippine Commission ay itinalaga ng Estados Unidos upang buwagin ang lahat ng mga ala-ala at mga bagay na nakarehistro sa ilalim ng pamahalaang Kastila at noong Nobyembre 6, 1906, pinagtibay ng Philippine Komisyong Estados Unidos ang Batas sa pagtatala sa mga Lupain Bilang 496 o mas kilala bilang Lands Registration Act na isinasaalang-alang ang legal na pagpaparehistro ng lupa sa ilalim ng pamahalaang Amerikano. Robert Torrens sa ilalim ng Survey Plan no. II-4509 ay nakatala na ang Pilipinas sa ilalim ng Orihinal na Sertipikadong Titulo ng Lupa Bilang 779 na may aktwal na sukat ng Pilipinas mula sa mga Isla ng Luzon hanggang sa mga Isla ng Sabah na pumapatak sa sukat na 452,000 kwadradong kilometro, sinukat din nila ang Sabah sa tulong ng pamahalaang Britanya ngunit ipinagbilin ng pamahalaang Britanya ang Sabah sa Malaysia at hindi ito ibinalik uli sa Pilipinas maliban na lamang kung lumitaw ang apong tagapagmana ng Sultan ng Sulu.



Sapagkat, Binigyan ng Estados Unidos ng Amerika ang Pilipinas ng pansamantalang kalayaan sa ilalim ng kanilang Commonwealth at alinsunod sa Tydings-McDuffie Act o mas kilala bilang Philippine Independence Act kung saan ang Pilipinas ay pamamahalaan ng lokal na mamamayan ngunit sa ilalim ng kontrol, hurisdiksyon at kapangyarihan ng Estados Unidos ng Amerika sa kabilang pagtalima para sa ganap na Kalayaan ng Pilipinas. Si Pangulong Manuel L. Quezon ang unang Pangulo sa ilalim ng Komonwelt ng Estados Unidos ng Amerika at ang 1935 Philippine Konstitusyon ay naaprubahan ng Estados Unidos ng Amerika.
